# D Planning Appeal

Ref: APP/D0840/W/22/3308997

Location: The Old Stables, Hayloft Courtyard, Lower Clicker Road, Menheniot, Liskard, Cornwall PL14 3PJ

Proposal: The appeal is made under section 78 of the Town and Country Planning Act 1990 against a refusal to grant planning permission. The application Ref PA21/09891, dated 4 November 2021, was refused by notice dated 14 June 2022. The development is Domestic (non-boarding) kennels outbuilding.

Decision: The appeal is allowed and planning permission is granted for Domestic (non-boarding) kennels outbuilding at The Old Stables, Hayloft Courtyard, Lower Clicker Road, Menheniot, Liskeard, Cornwall PL14 3PJ in accordance with the terms of the application, Ref A21/09891, dated 4 November 2021,

Received and noted. Cllr Cole has held discussions with the local Environmental Health Officer to raise continuing concerns about excessive noise, contamination of the water course and disposal of animal waste. Cllr Cole will liaise with local residents.

Update on East Road Allotments: ongoing issues with plot maintenance are being addressed directly by the councillor; several plots have become available and being offered to residents on the waiting list.

# 81/2023 Chair's Agenda Items

# A Councillors' Portfolios

Chair has been examining the current system of allocating extra responsibilities to councillors and is considering proposing that some individual offices are merged into larger working groups. These groups would spread out the workload, offer mutual support and streamline to process for carrying out tasks around the parish. Cllr Easterbrook welcomed the review, that some functions would benefit from being examined and possibly removed from the responsibility of the council. **Action**: Chair will prepare a briefing note for circulation before the July meeting.

## B Community Area Partnership 6 June 2023

The inaugural meeting of the new Community Area Partnership was held recently where 23 out of 29 parishes attended; Cllr Jane Pascoe was elected Chair; two sub-groups were agreed (Highways and Funding) and three working groups (Transport and Connectivity, Economic Growth and Development, Climate Action and Nature Recovery); the meeting had agreed a letter to the Department for Transport challenging their recent decision to postpone works on the A38.

# C Renewal of lease with Menheniot Sports Association

The draft of the lease is almost ready for approval by the parish council and Sports Association. The final iteration would see the access road removed from the lease, managed by the parish council, and with separate agreements made with the Sports Association and Cricket Club to fund its maintenance. This is part of a wider piece of work to assess the range of sporting facilities in the parish.

# A Vacancy for parish councillor

Although the current casual vacancy has now been filled (Item 74 above), Cornwall Council has today confirmed that it has not received any requests for an election to fill the vacancy caused by the resignation of Mr Tony Clarke.
