#### 136/2023 Chairman's Welcome.

### 137/2023 Apologies for Absence.

Apologies received from Cllr Curgenven.

#### 138/2023 Members' Declarations.

Cllr Goldsmith declared and interest in Item 141A, and was granted a dispensation to remain and participate in the meeting. No other declarations made or dispensations requested.

#### 139/2023 Public Participation.

No representations by members of the public.

#### 140/2023 Minutes of Meeting

It was **Resolved** to approve the minutes of the meeting held on 16 November 2023. Proposed Cllr Easterbrook. Seconded Cllr Luck. All agreed.

#### 141/2023 Planning

A To agree the parish council's response to Cornwall Council consultations on new planning applications received before the agenda was finalised.

Ref: PA23/07918

Proposal: Build a new floodlit tennis court with fencing. Replacement of existing halogen floodlights to LED floodlights on the existing MUGA.

Location: Football Ground East Road Menheniot Cornwall

Cllr Cole explained that he had received an update from the applicant, that: Sport England had lodged an objection to the application because it would have entailed reducing the size of the playing field; the Sports Association is in discussions with SE and the Planning Officer to resolve the issue, arguing that the field is not level, not the minimum size required for adult football games and have requested an extension to the deadline for decision. Councillors noted those arguments and **Resolved** to support the deadline extension and not make a final decision. Proposed Cllr Cole. Seconded Cllr Berg. All agreed..

Action: Clerk to inform Planning Officer of postponement.

#### PA23/08918

Proposal Conversion of a former mill building (Barn 1) into a single unit of residential accommodation with adjoining annexe and re-use of a traditional outbuilding (Barn 2) for general domestic purposes

Location Pathada Farm Menheniot Cornwall PL14 3RH

Councillors reviewed the application and agreed that Policy 6 of the Menheniot Neighbourhood Plan supported the proposal. It was **Resolved** to support this application. Proposed Cllr

Easterbrook. Seconded Cllr Ball. All agreed. They asked that Planning Officers should consider the potential impact that conversion to a residential dwelling might have on the water course.
