158/2023 Chairman's Welcome.

The Chair welcomed everyone to the meeting and asked that councillors and visitors should agree to wish King Charles III well in his treatment and recovery from his recently diagnosed illness. All agreed. Saturday 24 February is the second anniversary of the invasion of Ukraine by Russia: the Chair noted that the parish council will mark this by flying the Ukrainian flag on the village green and installing a display of flowers by the war memorial. Cllr Cole thanked Cllrs Ball and Goldsmith for their contributions.

159/2023 Apologies for Absence.

Received from Cllrs Curgenven and Berg.

160/2023 Members' Declarations.

Cllr Goldsmith declared his membership of the Menheniot Tennis Club (item 163A and 164A below). Chair noted. No other declarations made or dispensations requested.

161/2023 Public Participation.

Members of the public are invited to address the Council. (15 minutes)

Cornwall Councillor Phil Seeva sent a written report, that: at full council meeting held on 22 February 2024, councillor agreed a council tax increase of 4.99%; did not support an increase in tolls for crossing the Tamar; Cllr Richard Williams-Pears, Portfolio Holder for Transport has agreed to visit the parish to discuss reduced speed limits and issues around the Hayloft junction on the A38.

162/2023 Minutes of Meeting.

It was **Resolved** to approve the minutes of the meeting held on 18 January 2024. Proposed Cllr Easterbrook. Seconded Cllr Cole. All agreed.

163/2023 Correspondence

A Email from Menheniot Tennis Club requesting temporary extension to the use of the MUGA for a charitable fundraising event.

It was **Resolved** to support the request. Proposed Cllr Tucker. Seconded Cllr Easterbrook. All agreed. Chair asked that neighbours be informed if the council's decision to support. *Action: Clerk to write and update MTC*.

164/2023 Planning

A To agree the parish council's response to Cornwall Council consultations on new planning applications received before the agenda was finalised.

PA22/03642

Proposal: Hybrid application seeking full planning permission for erection of 202 residential dwellings (Use Class C3) together with associated landscaping, open space, access, and infrastructure and outline planning permission for up to 12 self-build plots Location: Land At Tencreek Farm Plymouth Road Liskeard, Cornwall PL14 3PS

It was **Resolved not to support** this application. Proposed Cllr Easterbrook. Seconded Cllr Cole. All agreed. Councillors noted these material concerns arising from Policy 4 of the Menheniot Neighbourhood Plan:

- The housing need justification does not reflect current community needs or demonstrate that the present infrastructure can cope with additional housing particularly as regards traffic impact.
- The new layout of the housing estate, its linkages, open spaces and architecture do not demonstrate an understanding of the site location and surrounding landscape.
- Integration of public transport within the community particularly to support any area of social focus or maximise accessibility to the service has not been delivered.
- The absence of a gateway landmark building has a significant impact on the identity of the development area.
- A comprehensive flood and pollution risk assessment is required now that all of the water discharge from the site (foul and surface) will discharge into the River Seaton directly or via natural water courses. In particular peak flow rates, the sub soil hydrology and the impact from adjoining sites and filtration of micro plastics at outfalls.
 Bus route access into the development utilising a circulatory connection will only occur on completion of next phases of development.
- There is no public space to act as a focus for social interaction across the development that includes a shop or social space.
- Policy 10 Night Skies has not been demonstrated as regards preventing light pollution causing a statutory nuisance to adjoining sites.
- Secure by design principles not demonstrated.
- The Air Quality Assessment appears to be based on lower numbers of vehicle movements than the transport assessment submitted. Concern that the impact on air quality will be greater than that shown.
