97/2021 Members' Declarations.

No declarations of interest made, or dispensations requested.

98/2021 Public Participation.

A Liskeard Town Councillor Simon Cassidy introduced himself to the meeting and explained that one of the key aims of his term in office would be to develop closer working relationships between his council and those adjacent to Liskeard. As part of this, he invited Menheniot councillors to attend his council meetings and is encouraging his own councillors to attend other councils' meetings. Cllr Tucker thanked him for his offer and asked that Menheniot councillors reciprocate.

B Cornwall Councillor Phil Seeva was unable to attend and sent a written report, that: he continues to Chair the Strategic Planning Committee; Cornwall Council is preparing to announce a number of redundancies in order to balance its budget; although there are proposals to close a number of leisure centres in Cornwall, Liskeard will remain open; he has visited the resident from Trewint who attended the September meeting to complain about speeding vehicles and will be returning to the area with a representative from Cormac next week; the Cormac representative will also be visiting the village green site to assess the flooding of this area; he has recently supported the purchase of a defibrillator for the Sports Pavilion. Any enquiries about further donations from his Community Chest can be made through the Clerk's Office. The Economic Growth and Development Overview and Scrutiny Committee met on October 5 to discuss proposals for a 20mph speed limit across the county: the Committee agreed to undertake a trial in selected villages that would be implemented by October 2022. At the time of writing, there is no information on the criteria for selection.

104/2021 Councillors' Reports

Cllr Adrian Cole delivered a progress report on climate change policy commitments, that: under Policy 1 (Leadership) Items 4 & 5 it had:

Received a quotation from a new electricity supplier but that it was unclear if the tariff was for a renewable source. Advised councillors to postpone a decision until this was clarified. Proposed that councillors agree to upgrade the lamps in the three street lighting columns it currently owns and maintains. It was **Resolved** to agree to replace the lamps as supplied by SSE Enterprise. Proposed Cllr Smith. Seconded Cllr Cole. All agreed.

Action: Clerk to progress replacement order and enquire with Cornwall Council about ownership of the street lighting on Bowling Green.

B Policy 1 (Leadership) Item 6: council has consulted with residents on its current ground maintenance contract (report published on 8 October 2021) and presented draft proposals for its new contract that would be offered for tender on 1 January 2022. Councillors discussed each of the proposals in the draft specification and agreed changes. The draft report will be published shortly and is open to comments up to 14 November. This report may be viewed on the council's website

Unable to attend the meeting but wrote to advise that the landmark tree would be best located in Trelawny Gardens.

Clerk presented a series of photographs showing all the new parish noticeboards now sited across all settlements in the parish. Cllr Easterbrook asked for a vote of thanks from councillors to Cllr Ball for all his work to install the boards and finger posts. All agreed.

Cllr Smith reminded councillors that the Community Emergency Plan had been circulated for comments and would be discussed and adopted at the next full council meeting.
