Thank you for your email.

You are correct in saying that the parish council have awarded a contract to a firm to carry out ground maintenance. This has long been the council's policy, and to my knowledge, it has never employed anyone directly to carry out this function.

I'm sorry that you do not find the work being carried to an acceptable standard on the verges at Trelawney Road. However, the cutting of all verges is not a responsibility of the parish council and is carried out by Cornwall Council. They have recently published their new policy on verge cutting — copy attached for your information. If you would like to report your concerns directly to them, they can be reached via this link:

I note your comments about the previous contractor. Councillors are bound to periodically reassess their contractors and suppliers, and the current contractor was appointed after a thorough and transparent tendering process which began last autumn. The parish council must as a condition of its Financial Regulations seek value for money on behalf of all its residents, and although it is not obliged to accept the lowest tender, did so in this case after taking references. The format of the contracts was designed to support small and independent businesses who may have wished to bid for the work, and so support those who may have been located

It is not within the remit of the parish council to discriminate against contractors and suppliers who may be located outside of the parish boundary, and the council would in breach of its duty to act fairly and responsibly were it to do so.
