Progress report.</li> <li>Steve Foster, Project Manager reports that by the close of the consultation on 31 March 2020, 21 responses had been received, 14 of which were from residents. Of these, 11 (78.6%) were in support, most (9 or 64.3%) making suggestions for modifications. Another 2 (14.3%) just wished to comment and only 1 (7.1%) response was opposed to the Plan. The Steering Group will give detailed consideration to the consultation responses and advise the Parish Council of any further evidence work that needs to be prepared before the NDP can be re-written and submitted to Cornwall Council. When the re-written NDP is ready the Parish Council will be asked to approve it for submission.</li> <li>B Community Governance Review</li> <li>Although the final consultation ended on 24 March, Cornwall Council officers are concerned that some parish councils had stopped public meetings before this date and have not commented on proposals.
