101/2022 Chairman's Welcome.

Vice Chair Cllr Easterbrook took the chair in the absence of Cllr Tucker.

102/2022 Apologies for Absence.

Received from Cllrs Clarke, Crocker and Cade.

103/2022 Members' Declarations.

No declarations of interest made, or dispensations requested.

104/2022 Public Participation.

Members of Merrymeet Residents Association attended to report that: they thanked the council for its recent donation to purchase spring bulbs; would be making a new application to have St Mary's Church, Merrymeet listed as a Community Asset and asked for the council's support; asked for clarification on projects to control speeding vehicles on the A390; requested a fresh supply of green/red assistance posters to distribute to residents.

Action: Clerk to deliver a quantity of assistance posters and promote their use.

Cornwall Councillor Phil Seeva reported that: he thanked the Royal British Legion for organising the Remembrance Sunday service in the previous week; had met with Sheryl Murray MP recently and had been assured that proposals for works on the A38 were progressing with news due in the new year; had met with planning officers in his capacity as Chair of Strategic Planning to discuss developments at Tencreek Farm and had been assured that Menheniot's Neighbourhood Plan was an essential part of their decision making; is continuing discussions with Cornwall Council leader relating to the withdrawal of the bus service.

105/2022 Minutes of Meeting.

It was **Resolved** to approve the minutes of the meeting held on 20 October 2022. Proposed Cllr Ball. Seconded Cllr Cole. All agreed.

106/2022 Correspondence

A Letter from Menheniot Scout Group asking for a donation to fund Christmas Carol Service. It was **Resolved** to donate £100 to the scout group. Proposed Cllr Cole. Seconded Cllr Berg. All agreed.

Action: Clerk to inform applicant and transfer funds.

107/2022 Matters Arising

A Increased water charges for public toilets (Item 94D)

Clerk presented chart showing the water usage since 2018 and councillors agreed that there was no obvious pattern to explain the changes in usage.

Action: Clerk will report a possible leak to South West Water. Cllr Smith agreed to install water monitors in both toilets and report back.

B Proposal for weed management at Merrymeet (Item 98A)

Councillors discussed the options for managing weeds across the parish and agreed that because there was no statutory requirement for the council to remove weeds, they would not fund this work. This will be included in the budget calculation for 2023/24. (See Item 109D below)

Proposal: Full planning for the erection of 202 dwellings and associated works The Chair reported that she had held a meeting with the planning officer responsible for Tencreek application, together with the Group Leader for Planning East Cornwall. They are aware of the

concerns of this parish council and have a copy of Cllr Coles' recent report (Item 111A below). They are currently negotiating with both Tencreek applicants in order to agree a masterplan that is acceptable to all parties (notably Policy 4 of the Menheniot Neighbourhood Plan). Cllr Seeva will be asked to comment on any new proposals as will councillors in Menheniot.

C Bank Reconciliation.

At the close of business on 31 October 2022, the parish council held £77,735.84 in its accounts.

D To approve the budget for 2023/2024

Councillors discussed the background to their budget setting, that: inflation is reported at 11.1% (4.2% in October 2021) and cost increases for substantial parts of the budget are already known. Clerk had already presented a briefing note setting out the options for increasing the precept or drawing on reserves to mitigate the impact. The meeting agreed that they would consider a precept increase of 10% with the balance of any shortfall being made up of cost reductions and transfers from the General Reserve. Concluding that no budget would be agreed, or precept set at this meeting but postponed until December 2022.

Action: Clerk to rework budget proposals and recommend a precept after further consultation with councillors.

E To approve the precept for 2023/2024

Agreed that this would follow after further consultation with councillors.

F Community Grant Application

It was **Resolved** to make a grant £250 to the Menheniot Tennis Club. Proposed Cllr Smith.

Seconded Cllr Coles. All agreed.

Action: Clerk to inform applicant and transfer funds.

A Christmas donation

Councillors discussed the proposal and agreed in principle to fund the donation of seasonal foodstuffs.

Action: Clerk to review costs and consult with councillors on a final budget.

111/2022 Councillors' Reports

A Cllr Adrian Cole

Community Network Area consultation, that: the mechanism for reforms and their delivery was not clear; current experience is that there is no joined-up work coordinated between the existing members of the CNA; the recent withdrawal of bus services from the parish is an example of how Cornwall Council and the CNA fail to engage or communicate with residents and their elected representatives; no confidence that this would be remedied in the new structure; communication between stakeholders is top down (from Cornwall Council to parish councils) and not bottom-up; Menheniot Green update: councillors received and noted the report.
